
What is the purpose of introducing a membership program?

You can understand from this figure how many frauds happen in our country and how many people are able to report. If we talk about only 2020, there were around 11,58,208 frauds cases reported (but according to NCRB, out of which there were only 50,035 cases registered) and in 2021 it was around 14,02,809 cases reported. Now you must have understood how rapidly cybercrimes are increasing.

After the covid lockdown, we have made more than 50000 people aware through online cybercrime awareness training, more than 10000 people aware through online webinars and offline workshops, through social media and other digital platforms, more than 30000 people have been made aware of new cyber frauds through social media posters and videos.






How to take Membership?

Note: If you donate more than Rs 2000/-, you can also be given an income tax exemption certificate, which you can avail in your income exemption. It is necessary to provide PAN card number to obtain the certificate for income tax exemption.

Rules and Regulation
